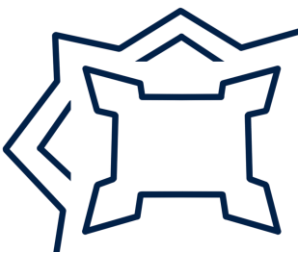
Thank you for your interest in Ticonderoga's Collections! To order an image reproduction, please fill out this form completely. All requests are subject to review and permission is granted at the sole discretion of "The Museum" (Fort Ticonderoga Association). This completed and signed form may be submitted by email, mail, or fax using the addresses above.

*Service Time:* While every effort is made to complete your request in a timely manner, most requests require two to four weeks to review and complete. Based on the information you provide, and the availability of existing photography, your request may be delayed beyond our standard service time. Requests processed in less than two weeks are considered rush jobs, and fees apply (see website for fee schedule).

*Delivery:* The Museum provides digital files sent to the User through a file sharing service for quick delivery. Other arrangements are available upon request, but applicable fees may apply.

### REPRODUCTION AND CREDIT POLICIES

- 1.1 The Museum has not determined copyright status for all objects and photographs in our collection, and is not responsible or determining copyright status or securing copyright permission. The Museum is acting only as the owner of the physical original. Possession of a reproduction from Ticonderoga's Collections does not constitute permission to use it.
- 1.2 The signer of this agreement agrees to defend, indemnify and hold The Museum, and its trustees, employees and agents, harmless from and against all losses, liabilities, judgments, awards, settlements, damages, fines, penalties and costs (including reasonable attorney's fees, expenses, actual damages, and loss of use) to any third party and all claims, causes of action and suits by third parties, arising from: (i) the use by the Photographer of any photographs taken pursuant to this Agreement, and/or (ii) any claim that the use of such photographs infringes, misappropriates, or violates any intellectual property rights
- 1.3 This agreement is valid for the individual project listed below. Rights to reproduce are non-exclusive and are granted for *one-time use only*. Permission to reproduce must be obtained in advance for each subsequent edition or reprint. Photographic material and the permission to reproduce images may not be reused, transferred, sold, or otherwise disposed of without written permission.

- 1.5 Each image must be reproduced unaltered and in its entirety unless approved in advance by The Museum. When a detail is used the word "Detail" must appear in the caption.
- 1.6 A complimentary copy of the publication in which the image is reproduced must be supplied to The Museum. A digital file in lieu of a hardcopy is acceptable.
- 1.7 The Museum reserves the right to deny permission to reproduce an image.



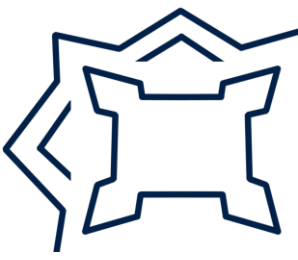

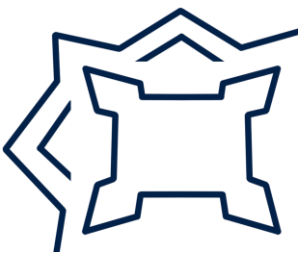
